Other Allowable Expenses (made at the request of the student):

4. Housing cost is based on living off campus. The Living Allowance component of the COA is constructed based on reasonable average expenses for a single student's housing and meals. The Living Allowance is adjusted for students living at home with their parents. Allowances for spouses or dependents of independent students are not included in the student's COA
